




The top graph reflects offenses occurrences retrieved from the Texas Department of Public Safety (TXDPS) Offense Distribution Report and reflects offense occurrences as reported by Harris County Sheriff's Office (HCSO), Houston Police Department (HPD), Pasadena Police Department (PPD) and Baytown Police Department (BPD). The bottom graph presents data retrieved from Harris County District Clerk's office (HCDC) and represents criminal cases filed in Harris County. Represented here are the figures from the month of January until month of January over the past five years for the categories of **Homicide, Aggravated Assault, Sexual Assault, and Weapons Violations.**

HOMICIDE:



Shows the number of homicide offenses that occurred from 2020 to 2024. Data was retrieved from Texas DPS NIBRS Offense Distribution for Crimes Against Person (Offense Attempted/Completed). Data was filtered for Pasadena PD, Baytown PD, HarrisCounty SO and Houston PD reports.

OFFENSE OCCURRENCES


In January 2020, Harris County law enforcement reported 32 Homicide offenses. This figure rose to 49 in January 2021, marking a 53.13% increase from the previous year. January 2022 saw a further uptick, with 62 reported offenses, indicating a 26.53% rise compared to January 2021. However, January 2023 witnessed a decrease to 49 reported Homicide offenses, representing a 20.97% decline from January 2022. Finally, in January 2024, the number decreased to 31 reported offenses, demonstrating a **36.73% decrease from January 2023**. Comparing the highest reported Homicide offenses in January across the five years, January 2022 holds the record with 62 reported offenses. This analysis unveils significant fluctuations in the count of Homicide offenses over the past five years, showcasing varied trends annually.

CASES FILED

The data reveals the count of Homicide criminal cases filed in Harris County from January 2020 to January 2024. In January 2020, 38 Homicide criminal cases were filed, which increased to 44 in January 2021, marking a 15.79% rise from the previous year. Subsequently, January 2022 witnessed a further increase, with 50 cases filed, indicating a 13.64% uptick compared to January 2021. However, January 2023 saw a slight increase to 51 filed Homicide cases, representing a 2% rise from the preceding year. Finally, in January 2024, the number decreased to 30 filed cases, demonstrating a **41.18% decrease from January 2023**. This analysis provides insights into the fluctuations and trends in the count of Homicide criminal cases filed in Harris County over the specified timeframe.




In January 2020, Harris County law enforcement reported 1,358 Aggravated Assault incidents. This figure increased substantially to 2.227 in January 2021, marking a significant 64.18% surge from the previous year. However, January 2022 saw a decrease to 2,113 reported incidents, indicating a 5.12% decline compared to January 2021. Further, January 2023 witnessed a decrease to 1,932 reported Aggravated Assault incidents, representing a 8.56% decline from January 2022. Finally, in January 2024, the number decreased to 1,632 reported incidents, demonstrating a 15.54% decrease from January 2023. Comparing the highest reported Aggravated Assault incidents in January across the five years, January 2021 holds the record with 2,227 reported incidents, while January 2024 has the lowest count at 1.632 reported incidents. 
SEXUAL ASSAULT

January 2022 saw a further uptick, with 341 reported offenses, indicating a 3.96% rise compared to January 2021. However, January 2023 witnessed a slight increase to 346 reported Sexual Assault offenses, representing a 1.47% rise from January 2022. Finally, in January 2024, the number decreased to 189 reported offenses, demonstrating a substantial 45.95% decrease from January 2023. Comparing the highest reported Sexual Assault offenses in January across the five years, January 2023 holds the record with 346 reported offenses, while January 2024 has the lowest count at 189 reported offenses. This analysis unveils significant fluctuations in the count of Sexual Assault offenses over the past five years, showcasing varied trends annually.


CASES FILED

The data illustrates the count of Sexual Assault criminal cases filed in Harris County from January 2020 to January 2024. In January 2020, 82 Sexual Assault criminal cases were filed, which dramatically decreased to 59 in January 2021, marking a notable 28.05% decline from the previous year. Subsequently, January 2022 witnessed a significant decrease, with only 54 cases filed, indicating a substantial 8,47% decline compared to January 2021. However, January 2023 saw a further decrease to 43 filed Sexual Assault cases, representing a 20.37% decline from the preceding year. Finally, in January 2024, the number increased slightly to 60 filed cases, demonstrating a 39.53% increase from January 2023. 
WEAPON VIOLATIONS

However, January 2023 saw a decrease to 538 reported Weapon Violations, representing a 14.44% decline from January 2022, Finally, in January 2024, the number decreased to 358 reported violations, demonstrating a significant 33,46% decrease from January 2023. Comparing the highest reported Weapon Violations in January across the five years, January 2022 holds the record with 629 reported violations, while January 2024 has the lowest count at 358 reported violations.
